administrative Ι have litigated numerous adversary proceedings before the City Hearing Examiner, the County Hearing Examiner, the Board of County Commissioners, the City Council, the City Planning Commission and the County Plan Commission. These matters consisted of administrative hearings on zoning issues, enactment of ordinances, application of local legislation, challenges to licensing and to regulatory matters concerning local businesses. Much of this work focused on the area of adult bookstore/entertainment regulation and zoning. I drafted the legislation, presented it to the legislative body, and subsequently successfully defended its constitutionality in both State and Federal Courts of Appeals.

On February 8, 2001 I was appointed to the position of District & Municipal Court Commissioner by the Spokane County District & Municipal Court Judges. I served for a year and a half in that capacity covering my assigned dockets and serving as a pro tem judge when I filled in for the judges in their absence. Since having been elected to the bench in 2002, I have handled every docket and assignment that the Court hears including: signing/reviewing felony complaints and search warrants, handling first appearance or inmate dockets for all felony and City and County misdemeanor defendants, jury and non-jury trials, small claims and civil motions and trials, infraction hearings, impound hearings, mental health and anti-harassment cases, domestic violence dockets, and all phases of criminal trials.

Additionally, I have worked on many District and Municipal administrative matters including drafting/reviewing court policies, forms, establishing court procedures and the formation of the new DUI Court.

14. State the qualities that you consider to be most important in an individual holding judicial office.

The following qualities are essential for judges to administer justice: a sense of fairness, impartiality, strong work ethic, the ability to digest complex legal facts and issues and explain them, often in lay terms. I also believe a level temperament is crucial to working with all of the individuals who appear in court. A good judge must have the ability to effectively communicate with and guide attorneys, pro se individuals, victims, various agencies and defendants, while at the same time effectively manage a considerable caseload. Strong leadership and a solid knowledge of the law are crucial to imparting justice.

My education and life experiences have afforded me the tools and common sense to be an effective judge. Growing up in countries like Lebanon and India, where human rights and access to justice were not particularly well defined or evenly implemented, gave me a great appreciation for our system of justice. The knowledge I gained as a prosecutor of sex crimes and violent crimes provided me with some expertise in assessing danger to the community. Knowledge of not only the law but the dynamics of these cases is particularly important in District Court where all of the felons are seen when first arrested and because large numbers of new attorneys are practicing in this court.

Working as a civil litigator helped provide perspective about the needs of our community and the importance of ensuring access by all to our court system. While great trial skills are imperative for the trial attorney, a good litigator must also be an effective mediator. As a District and Municipal Judge I have taken a leadership role in addressing all of these issues both from a civil and criminal perspective to ensure access to justice and a diverse approach to difficult issues. As an experienced judicial officer, I am not constrained by a learning curve. In my first term I was active in our association, our bench and our community. After seeing an opportunity to enhance the service of our court and safety of our community, I was instrumental in designing and implementing the new DUI Court, and am proud to be one of the first of two judges to be assigned to this court. These qualities of compassion, legal expertise and leadership coupled with an even judicial temperament are necessary to effect iustice.

20. State your reasons for seeking a judicial position.

I am seeking re-election to District & Municipal Court Position 4 because for the last 5 years I have tremendously enjoyed being a judicial officer. Service to our community is am important part of my life and I believe this position has enabled me to contribute in a very positive way to our community. Our charge as judicial officers is to effect justice. In my court each party to an action has a voice that is heard. Despite the fact that most days I will see more than 75 individuals in my courtroom, I am ever mindful that each litigant has a great deal at stake in each action and I endeavor in all cases to articulate a reasoned decision that has a solid legal foundation to ensure justice is done.

As a Rule 9 at the Public Defenders Office, a civil attorney and then a prosecutor, I was a zealous advocate for my clients/victims/citizens; as a judge one is able to take a more broad based approach to the problems and concerns of our community. In District Court we tend to see a lot of new attorneys and have the opportunity to set a high standard of achievement early in an individual's practice. It is in this court that many individuals will have their one and only brush with the law either as the accused or as a victim. If the justice system is able to function cooperatively and effectively the likelihood of keeping these individuals out of the system in the future is greatly enhanced. I have always enjoyed working with others and this court allows a team and a community focus on issues addressed by the Court. Both from a personal and professional standpoint, the work is extremely rewarding.

21. Please provide a statement of your personal experiences, awareness of and appreciation for the issues of equal access to justice, pro se litigants, and diversity.

During law school I worked as a law clerk and intern at the Spokane Public Defender's Office. I felt very fortunate and privileged during that time to have the opportunity to work with some of Spokane's less fortunate citizens at a crucial time in their lives. It was apparent to me then that individuals of lesser economic means do not always have equal or adequate access to justice.

As a volunteer in the Juvenile Court CASA Guardian Ad Litem Program working with abused and neglected children for nine years I witnessed the helpless predicament of many of our poverty stricken children. Often the child's primary caregiver was also the abuser opening a host of Hobson's choices for the child and the system. I later came to work with abused children as victims as a prosecutor of sex crimes against children at the Spokane County Prosecutors Office. While the focus of a prosecutor of child sex crimes is most certainly accountability of the offender and safety of the community, a great deal of effort went into ensuring the child was not further victimized by the court process. At the time this protection of victims was somewhat unique in our criminal justice system. This awareness of victims' needs and rights is now quite prevalent in our system, for example, in our now 10 year old **Domestic Violence Court.**

As a young lawyer I worked very closely with a very well respected individual in the legal field who quite plainly and unapologetically felt persons of color and alternative lifestyles were not equal in worth or intelligence. Lady Justice reminds us with her blindfold that the law should be applied without influence. These experiences strengthened my resolve to be mindful of the plight of those who are not empowered in our system. Equal and even application of the law is crucial. The Court's function as arbiter and seeker of justice cannot be met without understanding and skill in working with all aspects of the system to fairly and consistently apply the law.
