Service as a judge has been a great opportunity to be of help to the community and to work to keep families and the community safe. It is an opportunity to be a change maker in peoples' lives that has a direct impact on the quality of life of our community. I want to continue my contribution with my work both on and off the bench. My nine and one-half years on the bench have demonstrated that I have the qualities, skills, and experience to serve.

21. Please provide a statement of your personal experiences, awareness of and appreciation for the issues of equal access to justice, pro se litigants, and diversity.

Fundamental to these issues is that in a free society everyone must have a voice and an opportunity to be heard. Our system of justice is not complete unless it is available to everyone. This is an ideal held by many. Achieving this ideal is a difficult and complex process. Recently the Access to Justice Board, of which I am Chair, reviewed its principles and goals.

They are set forth at www.waaccesstojustice.org and encompass my view. Our state Supreme Court has stated that access to justice is a fundamental right. There must be an opportunity for meaningful participation and deliberation whenever legal needs, rights, and responsibilities are affected. Legal issues must be adequately understood, presented, and dealt with in a timely, fair, and impartial manner. Access to justice also depends on the availability of affordable legal information and services, including assistance and representation when needed. There must be adequate funding, resources, and support. Equal justice under the law requires that access to justice be available to all people. All persons or groups shall be afforded equal access to justice regardless of the popularity of the cause involved, status, or other considerations or characteristics.

In addition to observing these issues on a daily basis in court, my personal experience began as I served as a pro bono attorney to a limited extent in private practice. My education in the questions of access to justice began with my service on the board of the Legal Foundation of Washington and continues with my work on the Access to Justice Board. My appreciation of the need became clearer as the Legal Foundation board grappled with grant applications exceeding the six million or so dollars available. Ultimately, I participated with the Equal Justice Coalition education efforts of our Congressional Delegation and have helped raise the needed funds for state the Civil Legal Needs study. This study has lead in part to increased funding for Civil Legal Aid and the establishment of the Office of Civil Legal Aid.
