### What is your strongest area of legal expertise?

I think I am strong in the prompt analysis of evidentiary rulings while presiding. As a trial attorney, I have a strong emphasis on the elements of a crime in criminal law as well as the elements of proof in civil personal injury cases and real estate contracts.

What recommendations do you have for improving court system funding and administration?

The Superior Court has gone to an electronic filing system, mandatory for attorneys and recommended for pro se litigants. The system appears to be working to expedite filings for the participants and cutting down on court employee time for maintaining hard copy files. There are also fees associated with the filing of the documents and ex parte orders that assist the funding of the system. I would like to see the e-filing system adopted by the District Court and hopefully achieve the same result.

Also, many pre-trial hearings, such as civil discovery and pre-trial conference motions, could be done by telephone, saving staff time and attorney time.

What actions have you taken in the last five years on issues regarding access to the judicial system?

I have not taken any action regarding access to the judicial system in the past 5 years.

What recommendations do you have for increasing access to the judicial system (Civil and Criminal)?

The approximate time to get to a superior court trial is 18 months from the date of filing to the trial date. I think the civil jurisdictional limits of the district court should be increased to at least \$100,000. The District Court should also be able to hear unlawful detainer proceedings and class C felonies. By increasing the responsibilities of the District Court, lag time in the Superior court should be reduced.

Have you reviewed the General Rule Definition of the Practice of Law, and the Practice of Law Board's Work? – Do you have comments or ideas? Would you be in favor of the proposed Legal Technician Rule? This rule allows trained, tested and licensed non-lawyers to provide specifically defined legal services without supervision by a lawyer. Please explain.

The Legal Technician Rule would permit non-lawyers to provide limited legal services after training and passing an exam. It is my understanding that the areas of family law, elder law, housing and immigration are being considered as limited practice areas. I also understand that the practice will be limited to assistance in completing Washington state approved forms and guiding clients through court processes as opposed to advocating for the clients in court.

I think there is an unmet need in the State for many disadvantaged citizens to obtain legal services. With the training and testing requirements being outlined by the Practice of Law Board, the Legal Technician can help fulfill the gap for those that qualify for legal service clinics and those that cannot afford a private attorney.
